2. 企業對於溫室氣體管理之策略、目標及方法


Policy, strategy and target of GHG management

(1) 企業對於溫室氣體管理之策略

Our strategy for the management of GHG

我們視氣候變遷為企業永續的重點管理議題之一,訂定「能資源管理程序」及「溫室氣體盤查管理辦法」作為溫室氣體及能資源管理最高指導方針。我們擬定「管理方案」制定減量目標及計劃,持續推動節能減碳政策,包含採用節能燈具、汰換老舊耗電設備、設定空調溫度,鼓勵同仁節能減碳。

We regard climate change as a critical issue for sustainable development of the Company. Thus, "Energy and Resource Management Procedure" and "Greenhouse Gas Inventory Management Regulation" are developed as our guidelines for the management of GHG emission and energy consumption. We settle "action plan" every year about emission reduction for continual implementation of energy saving and carbon reduction activities such as application of energy saving lamps, removal the equipment of old and low efficient, turn down the air conditioner, and etc. We encourage colleagues to act for energy saving.

Our GHG emissions reduction target

訂定溫室氣體排放減量目標:每年度經行動管理方案可減掉溫室氣體排放量 5 公噸。我們將持續響應政府溫室氣體減量政策,搭配「管理方案」來設定公司整體的減碳目標,持續關注氣候變遷、訂定相關目標並展開相關行動方案。

Our target to GHG emissions reduction established is reduction 5 tons CO₂e annually by action plan. We response to the carbon reduction policy of government authority by implement the action plans. Our mission is continual contributing forces and setting up targets to react on the climate change issues.
